I believe that this can be done organically, building on the good works that have gone before and looking to the future in hope and the assurance of God's creativity in our lives. It would help our work so very much if more would volunteer for the numerous tasks that need doing. May God continue to bless us and guide us in the years ahead.

Meetings of the PCC

The following is a very brief summary of matters discussed during 2014:

Meeting 7 January 2014

Attendance: 15

Arrangements for the interregnum were discussed. Arrangements for the annual parochial church meeting were made. Funding for the updates to the audio system and electrical system at St Philips were discussed.

Meeting 1 April 2014

Attendance: 14

The annual accounts to be presented to the APCM were agreed. The parish profile, required for the advertisement of a new priest, was finalised. It was agreed to proceed with the update of St Philip's audio system.

Meeting 3 July 2014

Attendance: 15

The post of choirmaster at All Saints was to be advertised. It was agreed to proceed with minor repairs to stained glass windows at All Saints. Progress on repairs highlighted in St Philip's quinnquennial report was discussed.

Meeting 7 October 2014

Attendance: 11

The Church Commissioners grant of £32,000 was discussed. Personal alarms in All Saints and Saint Philips were discussed. Matters relating to the installation of the new priest were arranged. Further updates to St Philip's electrical/lighting system were discussed.

Meeting 25 November 2014

Attendance: 16

Financial reports were received. The response to the Church Commissioners was noted. The list of assistants for communion was agreed. Reports on the maintenance at All Saints and St Philips were discussed.

In addition to these full meetings, the Standing Committee met four times during the year to progress business matters.

Report of the Churchwardens 2014

We report on the condition of our two church buildings.

All Saints Church

The last Quinnquennial Report was carried out in November 2012 and received from the Architect in January 2013. The recommendations of the report are being dealt with in conjunction with All Saints Restoration and Development Trust as finance permits.

Roofs

All Saints church has seven roofs all of which are inspected during the year by our architect and appropriate church officers. Six of the roofs are lead. Of these six five have been restored over recent years. Church officers and members of the congregation carry out regular maintenance of the roof and gutters.

The Main Nave Roof

This has now been inspected due to some rainwater coming through. The Restoration Trust has discussed with the Architect how to access funding for the replacement of the roof. now that the formula funding from English Heritage has changed.

Roof over organ chamber

Discussions have taken place with the Architect about the Organ Chamber roof, who has advised that this work is not a priority. ~This will be addressed as funding becomes available.

North Parapet Last year some repair work was carried out and certificate issued is satisfactory.

Bells

These are functioning satisfactory since the last work was carried out.

Clock Chamber floor

A temporary repair which was completed .last year is still satisfactory. Further work will be needed to be carried out as and when funds are available.

Clock

This is working well at present.

Notice Board.

These notice boards are satisfactory and well used.

The Lightening Conductor has passed its annual test and has a valid Certificate.

Nave the new timber flooring in the front section of the Nave is satisfactory.

The flooring under the front pews on the north side is being investigated.

Curtains at West North West door are satisfactory.

Lighting. North Tower ad Turret Tower Electrical Work: This is functioning well since the system has been repaired. The porch light has a switch as well as a sensor. The lighting controls for the boiler room are now in the Vestry.

Flagpole

Flagpole –. This was taken away and restored and has now been replaced.

Rainwater disposal

Rainwater goods leave the church by way of soakaways. The church does not have main drainage. The Restoration Trust is to investigate any drainage around the church.

Miscellaneous

The new electrical power and lighting system which was installed in the church in 2008 is working well. This was funded by All Saints Restoration and Development Trust.

The Organ

The organ is used on a regular basis and is tuned at least three times each year. A Quinnquennial Report is received every five years.

Overview

The organ is generally in a good condition but, as with all instruments, regular tuning and maintenance is the key to long-term reliability. The organ is structurally sound and will continue to give good service for many more years. A major dismantling and cleaning overhaul should be considered in about 15 years time. The organ's great action motors have been re-leathered. The organ should be fully reliable for at least a further three years before further re-leathering is required.

Fire extinguishers

All Saints has a contract for the supply, maintenance and inspection of the appropriate fire extinguishers.

Churchyard

The churchyard is in the care of Maidstone Borough Council who are regularly advised when trees or vegetation become a threat to the church building. Maidstone Borough Council regularly spray the paths with an antifungal solution. They have removed two trees. The Holy bush is to be removed because of the problem with the roots near the church. Regular meetings are held with MBC to discuss the churchyard.

Doors

All doors function as required and are marked as exits on the Emergency Evacuation Plan displayed in the church and in service books as they are printed.

New Prinkel keys and locks which were fitted are in good order.

Heating

The heating system functions correctly although the temperature in the church does not always reflect this. Normally this is due to the fact that doors are left open thereby allowing heat to exit the building. Actions have been put into place to try and encourage people to close the doors. All Saints Restoration and Development Trust together with our architect are investigating possible improvements.

Window ventilators

The window ventilators situated in the chancel roof area function as required.

Audio System

The audio system works in accordance with its specification. However it is dependent on those using microphones to do so correctly.

Portable Appliance Tests have been carried out and dated.

Holy Name Chapel The carpet in the Holy name Chapel has been replaced as the old carpet was a health and safety issue.

Future repairs and restoration.

Some of the stained glass windows need repair and estimates have been obtained Work is expected to begin in the New Year.

Refurbishment of the Refreshment area will be put in hand as soon as it is possible.

Wall Paintings Restoration and Development Trust have endeavoured to find funding for this project. A Conservators report has given an estimate for this work but work cannot begin until funding is found.

St. Philip's Church

Quinquennial Report

A Quinnquennial Inspection was received from the Architect in June 2013. We are working towards the recommendations as finance becomes available.

Roofs

The North and South Elevation roof the gutters have been cleaned and minor repairs carried out. Smart water has been applied.

Stonework

The stonework problem at the Chanel end has been attended to. As soon as funds are available there are other parts of the Stonework that needs to be carried out. A quotation has been received for this work.

West Porch

Safety work to stonework over the west porch which was carried out is satisfactory. The roof and gutters have been cleared.

Entrance Hall Ceiling

The ceiling remains in good condition.

Disabled Access.

There is disabled access to the building.

Toilets

There is a Ladies and Gentlemen's Toilet. A suitable toilet is provided for the frail and some disabled. Plans have been drawn up for Toilets for the disabled; Friends will discuss how to proceed.

Ouiet Room.

The ceiling in the Quiet Room is still in good condition.

Coffee Bar

Ceiling in Coffee Bar is satisfactory but needs to be re-plastered as soon as funds are available.

Hall

Tiles are in fair condition.

Kitchen,

A new cooker has been fitted.

Lightning conductor

A Lightning Inspection has been carried out and a Certificate has been issued.

Rainwater goods generally

Rainwater Down pipes have regular checks by a member of the congregation.

Rainwater gullies

Work has been carried out to clear debris from the Gullies The building has Main drainage.

Electrical

An Electrical test and inspection has been carried out which failed to meet the standard. Quotations were obtained for both the Church and Centre and both have now been rewired with new lighting. .Certificates have been issued.

PAT

A Portable Safety check has been carried out on electrical appliances.

Church Floor

Repairs have been carried out to the floor as suggested in the Quinquennial.

Organ tuning/inspection

The Organ is used on a regular basis and is tuned three times a year.

Overview: This instrument is tonally particularly suited to the building able to lead a full congregation. The organ is in a good condition but with all instruments, regular tuning and maintenance is the key to long -term reliability. The organ is structurally sound and will continue to give service for many more years.

Fire extinguishers

There is a contract with Kent Fire Protection and a Certificate of Inspection has been issued.

Lighting

The Lighting in the building is very good following the re-wiring.

Vegetation close to church walls

Regular maintenance and removal of some trunks and clearance of vegetation has been carried out.

Church Grounds.

Gate fitted by the access for the disabled is still in good condition.

The Selling of the Land at the North side of the church has been discussed with the Diocese who put in planning for three dwellings. This failed to receive Planning Permission. There are no plans to sell for the time being.

Doors and door furniture in the Centre

All doors function as required all have illuminated Exits signs above them.

Heating /Boiler

The Boilers in the church and centre are regularly maintained.

The Boiler in the Church needs the Programmer to be looked at during the next year.

Drains.

Some work clearing the drain .has been completed.

Audio system

A new Audio system has been installed and is working very well. Radio Microphones have also been purchased.

Bell frame

St Philips has one bell which is rung regularly.

Clock The Clock is regularly maintained under contract.

Every matter that we have reported upon requires the time and skill of a small number of people to mitigate the cost of professional services. To everyone concerned we give our grateful thanks.

We continue to enjoy the space and facilities at Archbishop Courtenay Primary School. We have used some of the financial gift given by Ann King when she moved to Ireland, to purchase a set of communion silver and a beautiful new lectern, which enhances our worship and was dedicated by Clinton when they were used for the first time.

Services

On the retirement of both Christopher and Priscilla we have enjoyed a number of visiting priests to help us maintain our pattern of worship, with Robin Williamson being a regular priest, who particularly enjoyed joining us. Despite the reduced clergy available, thanks to Mollies organisation we have managed to continue to maintain the pattern of a Family Service on the first Sunday of the month and a Family Eucharist on the third Sunday.

All our regular congregation help by contributing to the services in some way, by serving, reading and intercessing, taking the Family Service, and most importantly making the coffee after the service. In December we undertook our first 'Messy Church', with a make your own Chrsitingle activity. This was well supported and a variety of activities were enjoyed by both children and adults alike. ALL SAINTS BELLRINGERS

I am pleased to say the bell installation is in excellent order, the only expenditure we have had is ordering of new bell-ropes, we currently order about 3 or 4 new ones per year.

The bell-ringing team is really doing well with mainly 8 or 10 bells being rung most Sundays during the year. Our two newest recruits, Isla and Christine are now at the stage where they can really be involved in the band, both now joining in to ring for Services. I would, however like a few more recruits, particularly youngsters who we can train up to eventually ring the very heavy tenor bells within the ring.

At Thursday practices, with the help of ringers from other towers, we continue to be able to ring 'methods' of great complexity, as far as we know not practiced in any other Church in the County.

The tower also continues to host a number of full peals per year, these are deeply engrained in the history of ringing at All Saints.

The bell-ringers continue to look after/ monitor the clock mechanism, it tends to gain but we stop it for a few minutes every 2 weeks or so.

PCC TREASURER'S REPORT and ACCOUNTS

Last year I said in my report that 2013 had been a very significant year in our parish. Well perhaps 2014 will be even more significant and not just because I am stepping down as Parish treasurer after over 20 years. We have a new Priest-in-Charge in Ian Parrish who has given us a new focus and direction in the short time he has been with us. From a financial point of view the most important development in our finances was that the Parish was the recipient of a Mission Grant (£32,963). This enabled us to pay our Parish Share in full and so the balance we owe the Diocese for past years remains unchanged at £177,894. The parish will receive a Mission Grant of £32,963 for a further 4 years (2015 to 2018 inclusive). This will give us an ideal opportunity not only to put the parish on a more secure footing but also to try and reduce our long outstanding debt to the Diocese.

The accounts are prepared on an accruals basis. This means they show the position if all income had been received and all expenditure paid by the end of the year. Detailed debtors and creditors arising from this are on page 21.

BALANCE SHEET page 16

The Balance Sheet is a summary of the Parish's net assets. The net assets at 31 December 2014 stood at £-136,450 (2013 £-134,767). Our net liability has increased slightly in the year.

This page summarises the Parish Ordinary and Extra Ordinary income and expenditure items that are shown in more detail on pages 20 and 21.

Ordinary Income (Page 20)

All Saints (including St Stephens)

Planned Giving for 2014 - £47,615(2013 -£46,544) has increased by £1,071 on 2013, an increase of 2.3% (2013 -0.1%). In addition Church collections have also increased by £1,411 up by 35.4% on 2013 whilst sundry donations have decreased by £320. Income from College Room was £890 a decrease of £305 on the previous year. I would also like to state that collections and giving from the congregation at St Stephens totalled £459 (2013 -£480), and only because of limitations in the presentation of these accounts, this amount is included with All Saints income.

St Philip

Planned Giving for 2014 - £11,547 (2013-£12,943) is down by £1,396 on 2013 a decrease of 10.8% (2013 -36.7%). Planned giving has fallen at St Philips for several years and is probably my biggest cause for concern as I hand over the reigns to the new Treasurer. Church collections (£889) have increased compared to 2013 (£631) but sundry donations (£338) have gone down by £432 compared to 2013, due to fewer fund raising events.

Gift Aid

The parish continues to try and maximise it's Gift Aid claim from the Treasury but can only do so if we ensure that all those who pay tax have signed the necessary paperwork. Please speak to Lionel if you think you could sign a Gift Aid Declaration and haven't yet done so. Remember we can claim an additional 25p for every £1 you donate under this scheme.

Ordinary Expenditure (Page 21)

Our expenditure decreased during 2014 from £110,061 to £103,484 a 6% decrease (2013 +1.0%). (Where expenditure is for both All Saints and St Philip, I have this year split it on a 80:20 ratio,(2013 78:22), which is based on the amount of planned giving at each church.)

All Saints

Total expenditure for 2014 was £85,142, a decrease of £2,869 on 2013.

There were increases at All Saints for Parish Share, Minor Repairs, Upkeep of Services, Church Hall and other.

Church Running expenses in total remained unchanged but another increase in insurance premiums was offset by a saving in heating bills, due to a new energy deal and a milder winter.

There were savings in Ministry (clergy) and Salaries (choir) as a result of changes of personnel in both categories.

St Philip

Total expenditure for 2014 was £18,342 a decrease of £3589 on 2013.

There were increases in Church Running expenses (insurance), upkeep of services and Young People. Savings of expenditure occurred in Ministry Clergy (as per AS), Minor repairs and Other.

Parish Share

In 2014 we were asked to contribute £65,269 towards the Parish Share, an increase of £2,209 (>3.5%). We paid £32,306 (49.5% of £65,269) in 2014 with the balance funded by a Mission Grant of £32,963. In 2013 we paid £32,000 (51% of £63,060) and our total unpaid quota remains unchanged at £177,894 (page 22).

All Saints with St Philip Extra Ordinary Account

This account continues to be used for income and expenditure of a one off nature. Movement in 2014 is as follows:- All Saints received a legacy from Edith Smith of £13,700. From this £10,700 was transferred to the All Saints Restoration Trust leaving a balance of £3,000 for use as agreed by the PCC. Please remember if you would like to leave a legacy to the Parish, please speak to Ian or Clinton or one of the Churchwardens who can help you through the process.

St Philips congregation donated £1040 following an appeal to fund a new sound system in the Church. St Philips Centre donated a further £6,395 towards the sound system and the balance of £741 was given from the legacies of Keith Reader and Margaret Standen (see more details below). The total cost of the sound system was £8,176 and all those who've heard it now wonder how we did without it for so long. St Philips Church also had to re-wire it's electrical systems in 2014. The church was able to use it's deposit account to pay the sum of £11,376. In addition charitable collections totalling £123 at St Philips were paid over to the Childrens' Society from a collection at the Christingle service.

The parish has also received the sum of £5,585 (split AS £4490 SP £1095) following the winding up of the Howard De Walden Charitable Trust. This Trust was set up many years ago to financially assist the "Curate" of the parish (Curate later became Vicar). Payment of clergy is now a Diocesan responsibility which is financed by parishes through their Parish Share. The amount received has therefore been paid to the Diocese as part of our Parish Share commitment for 2014.

St Stephen's - "The Church in the School" – The sum of £6,250 was donated at the end of 2011, by Mrs Anne King, for the purpose of purchasing equipment for St Stephen's new worship centre. Part of this donation was expended in 2014 on Godly play equipment and a chalice leaving a balance of £5,817.

St Philip Legacy – The Parish received two legacies in 2009 totalling £20,000 from Keith Reader and Margaret Standen. The final balance of £741 was used to help pay for the sound system as indicated above. A breakdown of the expenditure is shown on page 22.

Fee Account – This is a clearing account for monies received and paid under the headings shown including PCC Fees earned from weddings and funerals. It also includes monies received from use of All Saints Church by third parties which amounted to £9,887 (2013 - £8,915). This forms a significant part of AS income and we are most grateful to those who give up their time on a regular basis to enable the Church to be used in different ways. These sums are transferred to the main PCC account on a regular basis.

Community Account – The figures show a surplus of £26 (2013 – deficit £1,762) for the Parish magazine. This gives an accumulated fund of £402.

St. Philip Centre – The Centre has recorded a deficit of £6,750 (2013 – surplus £2,268) this year. However this is after the Centre contributed £6,395 towards the new sound system in the church. This gives an accumulated fund of £6,666. May I take the opportunity to say a big thank you to Janet Dredge who has stepped down after many years service as booking secretary for the Centre. Janet is to be commended for spending many a cold Monday night at St Philips waiting in hope for the odd Centre booking here and there but this has enabled the Centre to be in the good financial position it finds itself in.

All Saints Church Shop – The shop has recorded a small deficit of £51 and has also purchased some new stock during 2014.

All Saints Bellringers – The accounts show a surplus of £311 for the society for 2014 giving an accumulated fund of £3,565.

St Philip's Organ and Choir Fund –The balance of £3,354 (2013 - £2,002) carried forward relates to St. Philip's organ and choir fund (£631) and youth fund (£2,723). The PCC was pleased to receive a grant from the Community Development Fund of £1,750 which is for the benefit of youth in the parish. £338 was spent on youth work in 2014.

My thanks for one last time go to all those who work or have worked tirelessly behind the scenes banking and recording monies, keeping accurate records and ultimately helping me to produce these accounts for the last time. I trust that you will continue to help and support Lionel Marchant as he takes over.
